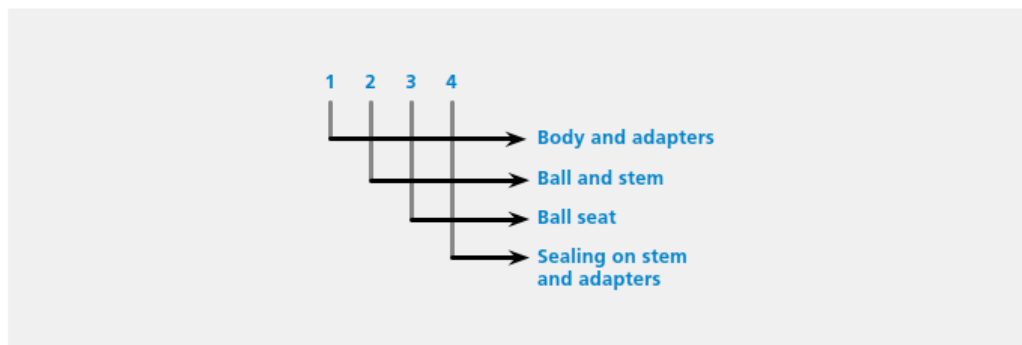
Hereby MHA ZENTGRAF GmbH & Co.KG confirms that the steel and stainless steel valves (complex product) do not contain substances from the most recent version of the SVHC "Candidate List of Substances of Very High Concern" above the 0.1% threshold level.

In the case of lead (CAS-No. 7439-92-1), this threshold value will currently still be exceeded at the component level (**adapter + stem**).

This affects products with the following material combination **x1xx and 1xxx** (see explanation below).

Please note that brass products may contain lead as an alloy, exceeding the 0.1% threshold. Lead was added to the SVHC list on June 27<sup>th</sup>, 2018.\*
